President's Report

On behalf of the Board of Directors, I am pleased to report that 2011 has been another successful year in the life of our Society. We sponsored six public events including our annual Genealogy Workshop. We began the year with a presentation of two Otto Klassen films dealing with the history of Mennonites in the early years of the Soviet Union and the Great Trek. Our third event was a film and lecture featuring Walter Ratliff's portrayal of the Trek to Central Asia and Claas Epp. Colin Neufeldt was the speaker for our Annual Banquet in October, continuing where he left off in 2010 with a description of the plight of Mennonites under Stalin in the early 1930s.

Our publications committee was very active in 2011, producing three very informative newsletters. Article topics included a review of the history of our society, the American Mennonite Relief Organization and the Birth of the MCC, A Russian Mennonite Wedding in Einlage, 1913, Mennonites and Jews in South Russia, Lev Tolstoy and Clarence Bauman: Sermon on the Mount Affinities, several perspectives on mental illness, a tribute to David Ewert, and a number of informative book reviews.

Last year we saw the departure of five board members. Fortunately, we were able to welcome three new board members – Bob Weinreich and Elmer Wiens, who were elected at last year's AGM, and Henry Wieler, who joined us during the year and has been nominated for election this year.

We continue to enjoy strong staff and volunteer support that has allowed us to collect, process and preserve historical information in a variety of forms. Our historical and genealogical collections are well-used by the public, and I know that many researchers, from amateur family historians to university scholars, have been well-served by our staff and volunteers.

Thanks to the generosity and loyalty of our constituency, we have again received the necessary financial support to maintain our programs. We are thankful for the support we have felt from our constituency, and will strive to provide the public with a variety of resources that we hope will meet their needs.

Main Projects

- 1. Digitizing projects
 - (a) Mennonitische Rundschau: Now digitized: 1880-90; 1925; 1938-41; 1949-2007. A new flatbed scanner has been purchased and consequently medium oversize issues are now being digitized.
 - (b) Der Bote: Digitized: 1924-36; 1963-64; 1966; 1970-72; 1974; 1976; 1980-83; 1986; 1988-2008.
 - (c) Canadian Mennonite: Digitized: 1954; 1956-63; 1998-2008.
 - (d) MB Herald obituaries: Digitized: 1996-2009.
 - (e) Yearbooks: We are in the beginnings of scanning conference yearbooks.
- 2. InMagic

Major progress has been made on entering archival data into the InMagic program. Volunteers have worked extremely hard at this project, and without the assistance of a professional archivist. We have received some invaluable help from Sylvia Stopforth of Trinity Western College.

3. Microfilm digitization

We have completed 30% of the digitization of EWZ microfilms, and volunteers have put In countless hours getting the work done. At this point 252 microfilms have been digitized, consisting of about 755,956 frames.

4. Indexing

MB Herald births and marriages are in an ongoing process of upgrading. Mennonitische Rundschau periodicals are being digitized.

Der Bote issues are being digitized and indices have been uploaded to the web. EWZ files are being prepared for the GRANDMA database. *Canadian Mennonite* marriages are now being indexed as well as births.

Wall of Remembrance

Several more plaques have been added to the wall; Jacob H. & Sara (Tiessen) Isaak; Abram J. & Maria (Thiessen) Friesen; John & Maria (Klassen) Enns. Many thanks to our donors.

Archival Committee

Volunteers met with Board members to discuss archival issues and problems. This will be an ongoing process, and meetings will be called as needed.

Website and Computer Technical Committee Report

Objectives: The committee was formed to discuss and implement improvements to the www.MHSBC.com website, and changes to the MHSBC computer facilities, scanners, software, etc.

After meeting with the committee, Elmer made changes to the website to make navigation more user friendly, and added a new web page with the MHSBC Mission Statement.

Don obtained/created copies of all MHSBC newsletters (Roots & Branches) and Annual Reports in PDF format, and these files were posted to the website.

We hope to get up-to-date photos of volunteers, staff members, and directors, with a short biography plus links to personal websites.

Don investigated getting a larger scanner for issues of Der Bote and Mennonitische Rundschau that do not fit the existing multi- function printer. A new scanner was purchased.

MHSBC has switched to Shaw's business website hosting package, with a wider band width and a faster speed connection. This change facilitates website viewers when downloading the newsletter PDF files, and provides greater storage capacity and enhanced website design features.

Corrections and updates are being made to the website as they are presented.

Future events are now also being posted to the www.MHSBC.com entry (home) web page to increase awareness by website visitors.

The committee also discussed finding sponsors and advertising, a matter that was brought up with the other board members.

Thanks to associate editors Robert Martens and Louise Bergen Price for many hours of writing and editing, and to Wilf Penner, Anne Andres, and Heather Murray Pauls for articles, practical advice and inspiration. Thanks to Heather Pauls Murray for doing layout; and to Mary Ann Quiring, Elisabeth Klassen and the volunteers at the archive office who complete the process, of stuffing envelopes, and addressing and sorting, stamping and mailing them to MHSBC members.

Our policy is to try to provide a broad range of articles so that all readers will find something of interest. We welcome receiving any of the following: letters and photos from the past; stories; book reviews; memoirs; biographies; articles of historical interest. Contributions can be in English or German (we will translate).

Accountant Review

To the Directors Mennonite Historical Society of BC Abbotsford, B.C.

I have reviewed the Balance Sheet of the Mennonite Historical Society of British Columbia as at December 31, 2011 and the Statement of Income and Expense for the year then ended. In so doing, I accepted the statements received from the Society's bank and the holder of its investments and did not conduct independent enquiries. The Society's accounting being conduced on a cash basis, I did not test for any liabilities outstanding as at year end.

In common with many charitable organizations, the Society derives part of its revenue from the general public in the form of donations and membership fees which are not susceptible to complete verification. Accordingly, my verification of revenue from these sources was limited to a comparison on a test basis of recorded receipts and bank deposits by the Society and I was unable to determine whether any adjustments might be necessary to donation revenues and membership fees and their impact on total revenues reported on the Statement of Income and Expense.

The Balance Sheet and the Statement of Income and Expense reflect fairly the financial position and the results from operations of the Society for the Year 2011.

Financial Report

During 2011, the supporters of the Mennonite Historical Society of B.C. ("MHSBC") have once again been most generous in their gifts of time and financial support that have allowed the MHSBC to end the financial year in a very strong financial position. Again the October Fund Raising Banquet was the main source of revenue for the year with net proceeds of \$24,219.

Total donations for the year were \$60,190 compared to a budget of \$62,442. Total income for 2011 was \$95,437 against a budget of \$94,342.

Total expenditures for the year were \$84,840 compared to a budget of \$94,342 a savings of \$9,502. The operating surplus totalled \$10,597 for the year and with the increase in the investment portfolio the MHSBC ended the year with an increase in Members Equity of \$22,801.

Again, the with generous support of our members with both in time and in funds the MHSBC has been able to carry out its mandate for another year and for that the Board of Directors are most grateful.
